K&B Global Total Return Fund ("the Fund"), is a sub-fund of Byron Alpha Funds Pic (the "Company")

(ISIN: IE00BF003G15)

Objectives and Investment Policy

- The investment objective of the Sub-Fund is to seek maximum long-term return, consistent with preservation of capital and prudent investment management. There can be no guarantee that the Sub-Fund will achieve its investment objective.
- The Sub-Fund seeks to achieve its investment objective by investing its assets primarily in a diversified portfolio of fixed income instruments of varying maturities (whether fixed or floating rate, corporate or government, including those rated below investment grade) listed on Recognized Markets across a global geographical area subject to limitations on the permitted exposure of the Sub-Fund in emerging market regions. The Sub-Fund will not be managed to achieve returns consistent with a benchmark and will not replicate an index. The average portfolio duration of the Sub-Fund will vary from positive 1 to 8 years based on the Investment Manager's expectations for interest rates.
- The Sub-Fund may invest directly in investment-grade and high yield fixed income securities. The Sub-Fund may also invest up to 30% of its assets in subordinated fixed income securities. A maximum of 40% of the Sub-Fund's assets will be invested in securities rated lower than Baa- by Moody's or BBB- by Standard & Poor's Corporation or Fitch Ratings (or, if unrated, determined by the Investment Manager to be of comparable quality).
- The Sub-Fund may invest directly no more than 50% of assets in fixed income instruments issued in emerging market countries, including but not limited to emerging market countries in Asia, Latin America, Eastern Europe, the Middle East and other such countries as determined from time to time by the Directors. As a result, an investment in the Sub-Fund should not constitute a substantial proportion of an investment portfolio and may not be appropriate for all investors. - The Sub-Fund is actively managed. The Sub-Fund will actively allocate to, and within, different asset classes and geographies based on their potential to generate income and capital growth within the portfolio, with the view of optimising risk-adjusted returns of the Sub-Fund. The Sub-Fund will not be managed to achieve returns consistent with a benchmark and will not replicate an index.

The risk and reward category selected above demonstrates where the Fund ranks in terms of its potential risk and return. The risk and reward category chosen above has been calculated by reference to the pre-determined risklimit against which the Fund is actively managed. The value of an investment in the Fund can go up or down. When you sell your shares, they may be worth less than you paid for them. The Fund's risk level reflects that as a category bonds are, in general, less volatile than shares, the Fund uses active risk management techniques and fluctuations in a number of factors, such as interest rates, exchanges rates and perceived credit quality of the bonds held may cause the value of your investment, and any income from it, to rise or fall. - The fund is employing BNP Paribas Securities Services for administration and depositary services in order to reduce any operational risks and increase the transparency of the fund.
